

To calculate your CLE hours:

1. Use the schedule online and the chart below to determine your CLE hours. If beside your state's number of accredited hours, it says "no addresses," that means you should calculate your hours by looking only at the panels you attended. If this is the case, the addresses by Sen. Ted Cruz and Gov. Nikki Haley, the Barbara Olsen Lecture with Sen. Ben Sasse, and opening remarks by Justice Alito therefore **DO NOT COUNT FOR CLE CREDIT**
2. If besides the state's number of accredited hours, it says "panels and addresses accredited" you **SHOULD** count the time for the addresses and the Barbara Olsen Lecture, and opening remarks into your CLE calculation.
3. The time the panel/address lasted is the amount of credits you earned by attending unless you must subtract for lunch for your state, such as in Illinois and Pennsylvania. I have tried to note all the states that make you subtract for lunch, but this information is available online as well.
4. For states with 50 minute hours: Colorado, Florida, Missouri, New Jersey, New York, Oklahoma, Rhode Island, Wisconsin, West Virginia. Add up all your hours, multiply by 60, then divide by 50 to get your hours earned.

**We do NOT apply to Alaska, Arizona, California, Rhode Island or New York. We are an approved provider for Arizona and California, and we are therefore not required to apply in those states. Alaska is fully a self-reporting state and does not require us to apply. Hawaii and New York are reciprocal approval states, so approval in other states confers approval**

in New York. Delaware and South Carolina are two such states where we have already been approved, and thus Hawaii and New York are already approved.
